

Competition Terms and Conditions

Competition Period and Details

The competition period begins at 9.00am (AEST) Monday, 2 September 2019. Entries to the competition close 12pm noon Wednesday, 11 December 2019.

All eligible entries must be fully paid by 12.00pm noon Wednesday, 11 December 2019.

The draw for two (2) competition winners will take place at 6.00pm on **Wednesday, 11 December 2019**.

All bookings, including individual, team of two (2) and team of four (4) are eligible for the prize and will be automatically placed into the draw.

Entry Restrictions

All entrants must be over the years of 18 on the date of entry.

The prize must be redeemed before 31 October 2020

Employees, board members and/or, associated persons of Give Where You Live Foundation and/or Kids Plus Foundation are not eligible for the competition. Formal Surf Coast Trek Champions of the Surf Coast Trek are not eligible and therefore, will not be included in the list of names for the random electronic drawer.

Entry Method

All participants who have booked a place in the Surf Coast Trek 2020, whether it be individual, team of 2 or, team of 4 during the Competition Period will be placed as individual entries into the draw. All valid entries will be placed into a random electronic draw.

Prize Details

The first two (2) valid entries randomly drawn from all entries received during the Competition Period will each receive one (1) travel prize for the winner and one (1) companion to Kuala Lumpur, Malaysia valued at up to AUD\$3,000 (incl GST).
